TERMS AND CONDITIONS

1 – Purpose

Signet S.r.l with registered office in Torino (Italy), at via Principe Amedeo, n. 12 has launched, by its website Inner Design (www.innerdesign.com), a Inner Light Contest to challenge the abilities of its members (the "Contest"). The goal of the Contest is the exhibition of interior design and lighting works ("Lighting-Works") on the 9th of April in Milan, during the first day of the Milano Design Week . The exhibition will be held at the Sole24Ore Headquarter in Lotto District (Milan) and it will consist of a Fuorisalone 2013 event. The Lighting-Works will be selected by Inner Design team at its sole and undisputable discretion among the works proposed by the Participants - as defined below – according to these terms and conditions. The participation to the exhibition will be free of charge.

2 – Eligible Participants and eligible Lighting-Works

- 2.1** The Contest is addressed to any designers, architects, students, brands, lovers (the "Participants") as long as registered to the Inner Design website (www.innerdesign.com) living in Europe at the date of the participation form.
- 2.2** The Lighting-Works can be prototypes but must be physically available. Each Participant or group of Participants can apply with one/more than one Lighting-works. Subject, shape, size, materials and technique of the Lighting-Works are up to the Participants and not restricted by any condition except for any material which might be dangerous, the Lighting Works must be manufactured in compliance with the standards provided by EU legislations in relation to electrical equipments. Moreover, the Lighting-Works mustn't be exhibited in other locations of Salone del Mobile and/or Fuorisalone 2013.

3 – Terms and Instructions for the participation

- 3.1** The participation form (available for download at www.innerdesign.com) must be completely filled in, signed by the Participant and sent to contest@innerdesign.com together with at least two pictures of the Lighting Works (300dpi) as from February 15th to March 12th 2013, 12.00 p.m. GMT+1. Only entries sent by email will be considered. Each Participant can decide to enclose extra documentation if the nature of the Lighting-Works and/or the material used for the manufacturing require it, in order to present the object in detail as clearly as possible to Inner Design team. The Participant declares to be aware that an incomplete or untruth or not in compliance participation form will be automatically disqualified from the Contest.
- 3.2** The Lighting-Works must be sent at the Participants 's expense and under their own risks and responsibility via mail/courier with registered receipt and must be delivered by April 2nd the latest to the following address: **Inner Design, Signet Srl, C/o Gruppo Sole24Ore, Via Busto Arsizio 36 – 20151 Milano**
- 3.3** The selection of Lighting-Works will be made by March 14th 2013. On March 15th 2013, selected Lighting-Works will be communicated to the winners by email and published on www.innerdesign.com.
- 3.4.** The selected Lighting Works shall be presented by Inner Design team to the Italian press during their exhibition.

4. - Exhibition of Lighting-Works

- 4.1** The exhibition will be curated by Inner Design team which will decide discretionally the details of the installation according to the nature of the selected Lighting-Works and to the characteristics of the location of the exhibition.
- 4.2** Signet S.r.l disclaims any and all liabilities regarding any theft, loss, and/or damage that the Lighting Works may undergo directly or indirectly during the their storage at Inner Design premises before the exhibition, the transportation from Inner Design premises to the Sole24Ore Headquarter, the installation and the exhibition of the Lighting-Works during the opening time of the Sole24Ore Headquarter except for the case of gross negligence or willful misconduct. It is understood that Signet S.r.l. shall not be liable for any damages occurred to the Lighting Works during their exhibition at the Sole24Ore Headquarter.
- 4.3** After the exhibition, the Lighting-Works will be sent back by Inner Design team to the winners at their own expenses and risks pursuant to the instructions to be provided by the Participants.

5 - Guarantees

- 5.1** The Participant guarantees his/her authorship of the Lighting-Work, the complete availability of it, and his/her total exclusivity of copy-right, including the right of publication of the relevant images, reproduction and market.
- 5.2** The Participant guarantees that the Lighting-Works do not infringe – directly or indirectly – any copyright or other rights of a third party, and declares to be aware that the Lighting-Works will be excluded from the Contest if it proves to have infringed any rights owned by third parties.
- 5.3** The Participant warrants that he has obtained the ownership or the license of all of the copyrights rights possibly necessary and/or any further intellectual property rights – including rights to utilization of the images – from any third parties (if any) who has cooperated at the Lighting-Works. Moreover, the Participant undertakes to keep Signet S.r.l. harmless and indemnified from any claims, actions, or demand from any third party, in relation to the Lighting-Works, as well as from legal expenses concerning the defense against these third parties.
- 5.4** The Participant gives Signet S.r.l., free of charge, the right to reproduce and publish images and/or video of the Lighting-Work. This material will be used for example for press office activities, promotion online and offline, and archiving of the participations forms. Signet S.r.l. also through Inner Design team are also given free of charge the right to use the Lighting-Works and relevant material for promotional purposes also in the future.
- 5.5.** The Participant warrants that the Lighting Work have been manufactured in a proper a safe manner and by material in compliance with the EU legislation in terms of electrical equipment. The Participant shall take harmless Signet against any claims, actions, or demand from any third party any and/or shall indemnify directly any third party – including Inner Design team - in case of any physical damages due to any defect of the electrical equipment used to manufacture the Lighting Works

6 - Treatment of Personal data

The Participants declare to be aware of the Italian decree law of 30 June 2003, n.196, art.13, concerning the treatment of perso-nal data acquired by Signet S.r.l (through Inner Design team) on the occasion of this Contest, for the purposes and activities connected to the carrying out of the Contest, including the realization of the exhibition and the publication on the websites www.innerdesign.com. The Participants expressly authorize Signet S.r.l and Inner Design team to use the data also by adding them to their own contacts database. The Participants have the option to apply, regarding the use of his/her personal information, the rights established by the Art. 7 of the already mentioned Italian decree law.

7 – Enforceable Law and Competent Tribunal

These terms and conditions are governed by Italian law and any dispute about it will be the exclusive jurisdiction of the Tribunal of Turin.
